Parking Fees collected for 2005: \$3,297.50 (as compared to 2004: \$6,721.00) – the next highest collection since 2001 was in 2003, which was \$4,790.50.

There continue to be 2 applications pending for Grace Tweiten grant awards for individuals needing work clothes. More information is needed in order to make a decision.

Guest Speaker: Dennis Lyon – North Dakota Client Assistance Program

Dennis explained that Client Assistance is an advocacy program for individuals seeking/using vocational rehabilitation services and independent living services. He indicated that eligibility is determined by identifying whether or not an individual has a disability (physical or mental impairment that is a substantial impediment to a major life activity). Dennis indicated that individuals with disabilities who are underemployed are also considered for services.

Dennis spoke briefly about individuals diagnosed with chemical dependency and how they may or may not be eligible for services, recognizing that an individual who is well-established in their recovery might not have functional limitations that limit one or more major life activities at a given time.

Other notable points:

 If an individual is receiving SSI or SSDI he/she is presumed eligible for vocational rehabilitation services.

- Individuals always have a right to re-apply for services.
- Residency requirements cannot be imposed so individuals applying for services can apply for services in another state.
- Expense of services is not a legitimate reason for denying services.
- Disagreeing with an employment plan is not a legitimate reason for denying services.
- Client assistance (CA) can request a fair hearing if client assistance doesn't agree with vocational rehabilitation's decision. CA can hire an attorney to represent the individual if warranted.
- CA can take vocational rehabilitation to District Court.
- CA is 100% federally funded.
- Individuals incur no fees for assessment to determine the possible presence of a disability. Other services are generally provided on a sliding fee scale.
- There's a Vocational Rehabilitation Project (121) for enrolled members of tribes who live on/off a reservation.
